Once TP has them all, the voting website will be put together by him. It is expected that TP will have the information within a few days and that the website will be ready by the end of the week.

It is decided that the voting will be open from at least December 13<sup>th</sup> - 31<sup>st</sup>. If the website is ready sooner, voting can be opened sooner, in order to give members as much time as possible to vote before the holidays.
